I do hereby authorize and request the issuing authority to issue any and all of the United States and foreign patents on the application or applications to the ASSIGNEE, its successors, and assigns as the assignee of the entire right, title, and interest in and to the same for the sole use and benefit of the ASSIGNEE, its successors, and assigns.

I do hereby covenant and warrant that I have full right to convey the entire right, title, and interest herein assigned free and clear of all license, encumbrances, and liens whatsoever, and that I have not executed and will not execute any instruments in conflict herewith.

I, for the consideration aforesaid, do hereby covenant and agree to and with the ASSIGNEE, its successors, and assigns, that we, our heirs, executors, administrators, or other personal representatives, shall and will do all lawful acts and things, make all rightful oaths, and make, execute, and deliver any and all other instruments in writing and any and all further applications, papers, power, affidavits, assignments, disclaimers, and other documents which in the opinion of counsel for the ASSIGNEE, its successors, and assigns, may be required or necessary in this or in any foreign country to effectually secure to and vest in the ASSIGNEE, its successors, and assigns, the entire right, title, and interest in and to the invention, inventions, or improvements, application or applications, patents, rights, titles, benefits, privileges, and advantages hereby sold, assigned, confirmed, transferred, and conveyed.
