or the legal equivalent thereof on said invention in any and all foreign countries, and the right to claim priority under any and all treaties and conventions to which the United States of America is signatory including the Paris Convention for the Protection of Industrial Property and the Patent Cooperation Treaty (PCT) of the World Intellectual Property Organization (WIPO) for such corresponding applications, or any division, continuation, renewal or substitution thereof, and as to letters patent and any reissue, re-examination or extension thereof, the same to be held and enjoyed by said Assignee, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by us, had this assignment not been made.

I hereby authorize and request the Patent Office of the United States and any and all foreign countries to issue any and all of said patents, when granted to Assignee as the Assignee of my entire right, title and interest in and to the same, for the sole use and enjoyment of Assignee, its successors, and assigns.

Further, I agree that I will communicate to Assignee, or its representatives, any facts known to me respecting said inventions, and testify in any legal proceedings, sign all lawful papers, execute all non-provisional patent applications, divisions, continuations, substitutions, renewals, and reissue applications, execute all necessary papers to cause any and all of said patents to be issued to Assignee, make all rightful oaths and generally do everything necessary or desirable to aid Assignee, its successors and assigns, to obtain and enforce proper protection for said inventions in the United States and in any and all foreign countries.

The undersigned further declares that all statements made herein of his own knowledge are true and that all statements made on information and belief are believed to be true; and


