## PATENT ASSIGNMENT

Pursuant to a separate agreement by and between Jonathan Nichols, a US citizen residing at 2712 County Rd 21, Maplesville, AL 36750, Darrel Siebert, a US citizen residing at 6530 Alabama Highway 22 North, Valley Grande, AL 36701, Fred Daniel Oglesby, a US citizen residing at 1885 County Road 69, Selma, AL 36703, and Dawson W. Hastings, a US citizen residing at 238 Hardin Drive, Selma, AL 36701 (collectively, "**ASSIGNORS**," and each, an "**ASSIGNOR**"), and Alamo Group Inc., a Delaware corporation having its principal place of business at 1627 East Walnut, Seguin, TX 78155 ("**ASSIGNEE**"), and for the sum of ten dollars (\$10) and other good and valuable consideration paid to each ASSIGNOR, the receipt and sufficiency of which is hereby acknowledged, ASSIGNORS and ASSIGNEE acknowledge and agree as follows:

1. Each ASSIGNOR has assigned, and does hereby assign, to ASSIGNEE, its successors, legal representatives and assigns, ASSIGNOR's entire right, title and interest in, to and under:
  - a. U.S. Provisional Patent Application Serial No. 62/458,939 filed February 14, 2017 and entitled MOWER WITH ROTARY CUT HEIGHT ADJUSTMENT, and naming such ASSIGNORS as inventors (the "**'939 Application**");
  - b. U.S. Non-Provisional Patent Application Serial No. 15/896,825 filed February 14, 2018 and entitled MOWER WITH ROTARY CUT HEIGHT ADJUSTMENT, and naming such ASSIGNORS as inventors (the "**'825 Application**"); and
  - c. all subject matter disclosed therein ("**Inventions**");
  - d. all applications claiming priority to the '939 Application and/or the '825 Application (collectively, the "**Applications**") or disclosing any of the Inventions, and all divisionals, renewals, continuations, and continuations-in-part thereof, and all Letters Patent of the United States which may be granted thereon and all reissues, reexaminations, and extensions thereof, and all rights of priority based thereon, and all applications for Letters Patent and equivalents thereof which have been or may hereafter be filed for said Inventions in any country or countries foreign to the United States, and all Letters Patent which may be granted for said Inventions in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and
  - e. all rights of action for past, present and/or future infringement based on or otherwise related to the Applications or any United States or foreign Letters Patent related to the Inventions and/or unauthorized use of the Inventions (including without limitation any action for damages, legal, equitable or other relief) (the "**Rights of Action**").
2. ASSIGNORS hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent and similar forms of protection for said Inventions to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.
3. Each ASSIGNOR, for such ASSIGNOR but not for any other ASSIGNOR, represents and warrants that it (a) has full right to convey the entire interest herein assigned, (b) has not executed, and will not execute, any agreement in conflict herewith, and (c) will not challenge or dispute the ownership, validity or enforceability of the Applications or any Letters Patent or similar form of protection that may issue for the Inventions, or the Rights of Action, either directly or indirectly, nor allow any person or entity under such ASSIGNOR's control to do so.
4. Each ASSIGNOR will, and will cause persons under such ASSIGNOR's control to, communicate to ASSIGNEE, its successors, legal representatives and assigns, any facts known to such ASSIGNOR respecting the Inventions and the Applications, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, legal

representatives and assigns, to obtain, enforce and protect the Rights of Action, the Applications, and the Inventions in all countries, provided only that ASSIGNEE shall pay, or reimburse such ASSIGNOR for, all reasonable out of pocket expenses incurred by such ASSIGNOR incident to the performance of its obligations under this paragraph.

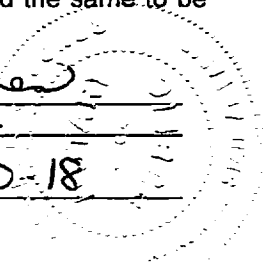

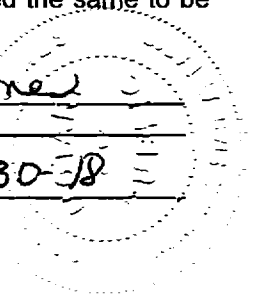

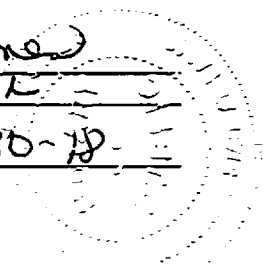
