IN WITNESS WHEREOF, the undersigned has caused this Confirmatory Patent Assignment to be duly executed and delivered on this 1 day of June, 2015.



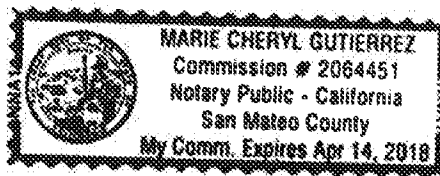
