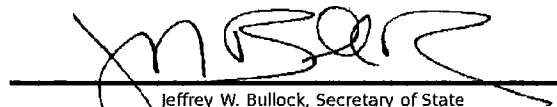

**CERTIFICATE OF OWNERSHIP**

**MERGING**

(Pursuant to Section 253 of the General Corporation Law of Delaware)

Smule, Inc., a corporation incorporated on the 18th day of June, 2008, pursuant to the provisions of the General Corporation Law of the State of Delaware (the "Corporation");

**DOES HEREBY CERTIFY** that the Corporation owns 100% of the capital stock of Khush Inc. ("Khush"), a corporation incorporated on the 21st day of November, 2011, pursuant to the provisions of the General Corporation Law of Delaware, and that the Corporation, by a resolution of its Board of Directors duly adopted at a meeting held on the 19th day of March, 2014, determined to and did merge Khush into the Corporation, which resolution is in the following words to wit:

**WHEREAS** the Corporation lawfully owns 100% of the outstanding stock of Khush, a corporation organized and existing under the laws of Delaware; and

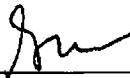
**WHEREAS** the Corporation desires to merge Khush into the Corporation, and to be possessed of all the estate, property, rights, privileges and franchises of said corporation.

**NOW, THEREFORE, BE IT RESOLVED**, that the Corporation merge Khush into the Corporation, and assumes all of its liabilities and obligations;

**FURTHER RESOLVED**, that an authorized officer of the Corporation be and he is hereby directed to make and execute a certificate of ownership setting forth a copy of the resolution to merge Khush into the Corporation, and to assume Khush's liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County; and

**FURTHER RESOLVED**, that the officers of the Corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware; which may be in any way necessary or proper to effect said merger.
