## DEED OF ASSIGNMENT

WHEREAS the undersigned:

**KYOUNG SU LEE**, having an address at c/o 966 Goyang-ro Wolgot-myeon, Gimpo-si, Gyeonggido, Republic of Korea

(“**LEE**”);

has made or contributed to the making of a certain new and useful invention (the “**INVENTION**”) as disclosed in:

United States Patent No. US D694,503, entitled **CRAMPONS**, filed in the United States Patent and Trademark Office on April 23, 2012

(the “**PATENT**”);

AND, WHEREAS LEE is an official and/or an employee of:

**LIFESPORTS CO., LTD.**, a Korean corporation having an office at 160, 117 Beon-gil, Goyang-ro Wolgot-myeon, Gimpo-si, Gyeonggido, Republic of Korea

(“**LIFESPORTS**”);

AND, WHEREAS LEE wishes to assign to LIFESPORTS his right, title and interest in, to and under the PATENT;

AND, WHEREAS LIFESPORTS wishes to assign, as a tenant-in-common, 50% of its right, title and interest in, to and under the PATENT to:

**HILLSOUND EQUIPMENT INC.**, a company incorporated under the laws of the Province of British Columbia, Canada, having an office at 221-2323 Quebec Street, Vancouver, BC V5T 4S7, Canada

(“**HILLSOUND**”);

AND, WHEREAS HILLSOUND is desirous of acquiring and of confirming that it has acquired, as a tenant-in-common, 50% of all right, title and interest in, to and under the PATENT;

NOW, THEREFORE, in consideration of the foregoing premises and for the sum of One Dollar (\$1.00) and other good and valuable consideration paid from LIFESPORTS to LEE and from HILLSOUND to LIFESPORTS (the receipt and sufficiency of which is hereby acknowledged by LEE and LIFESPORTS):

- (a) LEE hereby confirms that he has sold, assigned and transferred, absolutely, and by these presents does hereby sell, assign and transfer, absolutely, to LIFESPORTS, the entire right, title and interest in, to and under the PATENT (the “**PATENT RIGHTS**”), which **PATENT RIGHTS** include without limitation:

- (i) all right, title and interest in any renewals, re-examinations, reissues or extensions of the PATENT;
- (ii) the right to claim available benefits under the *International Convention For The Protection of Industrial Property*, and any like treaties or laws;
- (iii) all income, royalties, damages, profits and payment now or hereafter due or payable with respect to the PATENT; and
- (iv) the exclusive right to bring or participate in any proceeding for past infringement or any other actionable right under all of the foregoing and to receive all remedies that arise therefrom,

the same to be owned, held and enjoyed by HILLSOUND, its successors, assigns and legal representatives, as fully and exclusively as it would have been held and enjoyed by LEE had these sales, assignments and transfers not been made.

- (b) LIFESPORTS hereby confirms that it has sold, assigned and transferred, absolutely, and by these presents does hereby sell, assign and transfer, absolutely, to HILLSOUND, as a tenant-in-common, a 50% interest in, to and under the PATENT RIGHTS, the same to be owned, held and enjoyed by HILLSOUND, its successors, assigns and legal representatives, as fully and exclusively as it would have been held and enjoyed by LIFESPORTS had these sales, assignments and transfers not been made.

Each of LEE and LIFESPORTS hereby agrees to sign and deliver all lawful papers and to take all other lawful steps which HILLSOUND, or its successors, assigns or legal representatives, may request to give full effect to the intention expressed in this deed and to enforce its rights in the PATENT against others, including, without limitation:

- (a) to co-operate to the best of their ability in the execution of all lawful documents, the production of evidence and providing any additional assistance reasonably required in any reissue, extension, nullification, impeachment or infringement proceedings involving the PATENT; and
- (b) to do such further acts and things and execute and deliver to HILLSOUND, or its successors, assigns or legal representatives, such further instruments, specific assignments and other documents as HILLSOUND, or its successors, assigns or legal representatives, acting reasonably, requires to vest, effect, perfect, register, record, verify, evidence, enforce or protect its or their rights and interests in the PATENT.

Each of LEE and LIFESPORTS hereby agrees that this assignment shall be binding upon their respective heirs, successors, assigns and legal representatives.

The undersigned hereby authorize the firm of Gowling WLG (Canada) LLP to correct errors in this assignment or to insert any further identification or other information necessary or desirable to make this assignment suitable for recordal in any country.
