ASSIGNMENT

renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Stratospheric Platforms Limited, make all rightful oaths and generally do everything possible to aid Stratospheric Platforms Limited, its successors and assigns, to obtain and enforce proper protection for said invention in the United States.






