AND WE HEREBY covenant that we have full right to convey the entire right, title and interest herein sold, assigned, transferred and set over;

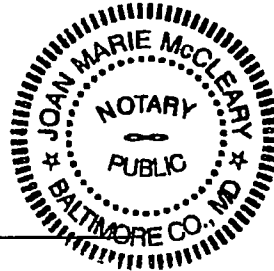

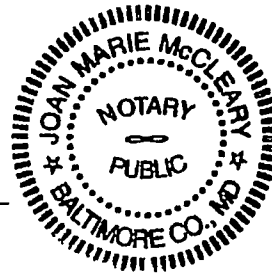
