

AMENDED AND RESTATED CERTIFICATE OF INCORPORATION  
OF  
CREATIVE VASCULAR, INC.**

The undersigned, Eric Stone, hereby certifies that:

1. He is the duly elected and acting President of Creative Vascular, Inc., a Delaware corporation.
2. The corporation was formed upon the conversion of Creative Vascular, LLC from a limited liability company to a corporation on October 1, 2013 pursuant to the Certificate of Conversion and Certificate of Incorporation filed with the Secretary of State of the State of Delaware on such date. The last Amended and Restated Certificate of Incorporation of this corporation was filed with the Secretary of State of the State of Delaware on October 2, 2013.
3. Creative Vascular, LLC was originally formed on October 10, 2011 as a limited liability company under the name Creative Vascular, LLC pursuant to the Delaware Limited Liability Act.
4. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment of the Amended and Restated Certificate of Incorporation amends Article FIRST of this corporation's Amended and Restated Certificate of Incorporation to read in its entirety as follows:

"That the name of this corporation is Velano Vascular, Inc. (the "**Corporation**")."

- 5 The foregoing Certificate of Amendment has been duly adopted by this corporation's Board of Directors and stockholders in accordance with the applicable provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
