

We hereby authorize and request the Patent Office officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said VKR Holding A/S as the assignee of our entire right, title and interest in and to the same, for the sole use and behalf of said VKR Holding A/S, its successors and assigns.

Further, we agree that we will communicate to said VKR Holding A/S or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisionals, continuations, substitutions, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said VKR Holding A/S, make all rightful oaths and generally to do everything possible to aid said VKR Holding A/S, its successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
