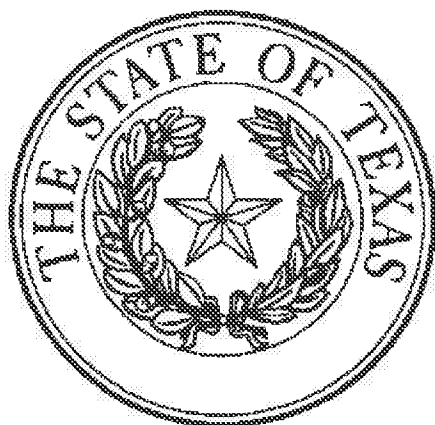

Pursuant to the provisions of Chapter 10 of the Texas Business Organizations Code, and the title applicable to each domestic filing entity identified below (the "TBOC"), the undersigned entities do hereby certify the following Certificate of Merger adopted for the purpose of effecting a merger in accordance with the TBOC:

**FIRST:** The name, organizational form, state of formation and if any, the file number issued by the Secretary of State of the State of Texas of each of the undersigned entities that are a party to the merger are as follows:

**SECOND:** An Agreement and Plan of Merger (the "Merger Agreement") has been approved, adopted, executed and acknowledged by each of the undersigned parties as required by the laws under which each entity that is a party to the merger was formed and by its governing documents.

**THIRD:** Pursuant to the Merger Agreement, Downhole Technology LLC, a Texas limited liability company (the "Non-Surviving Entity"), shall merge with and into National Boss Hog Energy Services LLC, a Texas limited liability company (the "Surviving Entity"), and the Surviving Entity shall continue to exist after the merger as the surviving company under the name "Downhole Technology LLC".

**FOURTH:** An executed copy of the Merger Agreement is on file at the principal place of business of the Surviving Entity at 7451 Breen Drive Houston, TX 77086 and the Merger Agreement will be furnished by the Surviving Entity, on written request and without cost, to any owner of any entity that is a party to the Merger Agreement and to any creditor or obligee of the parties to the merger at the time of the merger if a liability or obligation is then outstanding.

**FIFTH:** The certificate of formation of the Surviving Entity shall be amended to reflect the change of its name from National Boss Hog Energy Services LLC to Downhole Technology LLC.

**SIXTH:** No domestic or other entity is to be created pursuant to the Merger Agreement.

**SEVENTH:** The merger shall become effective upon the filing of this certificate with the Texas Secretary of State.

**EIGHTH:** The Surviving Entity shall be responsible for the payment of all applicable filing fees and franchise taxes, if any, of the Non-Surviving Entity, and the Surviving Entity shall be obligated to pay such fees and franchise taxes if the same are not timely paid.
