

Capitalized terms used but not defined herein shall have the meanings set forth in the Credit Agreement.

WITNESSETH:

WHEREAS, in connection with the Credit Agreement, (i) Babcock, The Babcock & Wilcox Company ("<u>B&WCo</u>"), Diamond Power International, LLC ("<u>Diamond</u>"), Babcock & Wilcox Megtec, LLC ("<u>B&W Megtec</u>"), Megtec Turbosonic Technologies, Inc. ("<u>Turbosonic</u>"), Babcock & Wilcox Universal, Inc. ("<u>B&W Universal</u>") and Babcock & Wilcox Technology, LLC ("<u>B&W Technology</u>" and collectively with B&WCo, Diamond, B&W Megtec, Turbosonic and B&W Universal, the "<u>Grantors</u>"), the other subsidiaries of Babcock from time to time party thereto and the Administrative Agent entered into that certain Second Lien Pledge and Security Agreement dated as of August 9, 2017 (the "<u>Pledge and Security Agreement</u>"); and (ii) the Grantors and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Patents dated August 9, 2017, which was recorded with the United States Patent and Trademark Office ("<u>USPTO</u>") on August 10, 2017 at Reel No. 043515, Frame No. 0001 (the "<u>Patent Notice of Grant</u>", and collectively with the Pledge and Security Agreement, the "<u>Security Agreements</u>");

WHEREAS, pursuant to the Security Agreements, the Grantors granted and pledged to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of the Grantors' right, title and interest in and to all of the Collateral (as defined in the Pledge and Security Agreement), including but not limited to the patents and applications set forth on Schedule I attached hereto, together with all rights to, and to obtain, any reissues or extensions thereof and all proceeds thereof (collectively, the "Patent Collateral");

WHEREAS, the Grantors desire that the Administrative Agent terminate and release any and all right, title and interest it may have in the Patent Collateral pursuant to the Credit Agreement and the Security Agreements, and the Administrative Agent has agreed to do so; and

WHEREAS, the Administrative Agent has duly authorized the execution, delivery and performance of this Release.
