ASSIGNMENT AND TRANSFER

WHEREAS, I, STEVE ISCOE (318 Palace Road, Kingston, ON, K7L 4T3), whose full post office addresses is set forth above, am the creator of Intellectual Property as hereinafter defined including, without limitation, inventions with respect to which I am the inventor;

a) all inventions (whether patentable or not) and embodiments thereof, technical information, technologies, copyrights, trade-marks, official marks, industrial designs, formulae, computer software and documentation, plans, methodologies, architectures, lab books, algorithms, notes, protocols, logos, trade names, computer hardware, databases, drawings, graphics, designs, apparatus, processes, materials such as cell lines, antibodies and other tangible research materials and devices, data, results, conclusions, observations, discoveries, patents and patent rights (including, without limitation, utility patents, utility models, patents of addition and design patents), know how, moral and similar rights, mask works, trade secrets, procedures, source and object

codes, programs, other works of authorship, organisms, plasmids, expressions, vectors, advancements, developments, techniques, compounds, molecules, chemical, biological and other material and their progeny, clones and derivatives, including, without limitation all genetically-engineered plants and animals;

b) all copyrightable works of authorship; and

c) all registrations of, and applications to obtain protection for and register, any of the foregoing with any governmental authority and any renewals, re-examinations, re-issues, extensions, divisions or continuations or continuations-in-part thereof, including all applications claiming priority therefrom and all foreign counterparts, continuations and continuations-in-part of any such applications.

NOW THEREFORE, in accordance with and as required by the APS, and in consideration of the sum of \$2.00, and other good and valuable consideration, all of the foregoing being hereby acknowledged as having been received, I the Innovator by these presents hereby irrevocably assign and transfer unto SSIP the entirety of my rights, title and interests in Canada, the United States of America and all other countries in the world to the Intellectual Property, to any modifications and improvements in the Intellectual Property contemplated, conceived, made or created on or before the date of execution of this Assignment and Transfer and to all Intellectual Property used specifically in aid of the conception, reduction to practice, development, implementation and commercialization of the aforementioned inventions and embodiments thereof, the aforesaid rights, title and interest to be deemed to include, without limitation, priority and other rights under international and regional conventions for the protection of intellectual and industrial property rights, and rights to assert remedies and make all claims pertaining to past interference with such rights, title and interest, including, without limitation, claims for damages with respect to any past infringement or breach of any such rights.

And for such good and valuable consideration received, I, the Innovator, do hereby irrevocably waive all of my moral rights and similar rights associated with all works authored or created in aid of the conception, reduction to practice, development, implementation and commercialization of the Intellectual Property or embodiments thereof, including without limitation, those works to which any aforementioned copyright attaches, all in favour of SSIP and its successors in title and confirm that I retain no rights whatsoever in such works.

I, the Innovator, further agree that I will without further consideration do all such things and execute all such documents as may be necessary or desirable to obtain and maintain intellectual property protection for any and all of the Intellectual Property and for the aforesaid additions, modifications and improvements thereto in any and all countries, and to vest title thereto in the said assignee, being SSIP, its successors, assigns and legal representatives or nominees.

I, the Innovator, acknowledge having read and understood the foregoing and having been given an opportunity to consult with legal counsel and have either done so or determined that such consultation is not necessary.

This Assignment and Transfer may be executed in any number of counterparts, each of which shall be enforceable, and all of which together shall constitute one Assignment and Transfer.
