## **CONFIRMATORY ASSIGNMENT**

WHEREAS, we, Callie Christensen, of Vancouver, Washington, United States, and Kelly Oriard, of Vancouver, Washington, United States, believe that we are the inventors of certain improvements in a PLUSH TOY (design), for which a patent application having the above-indicated title was or will be filed with the U.S. Patent and Trademark Office on June 25, 2018 as Serial No. 29/654,525 (“the Present Application”); and

WHEREAS, the Present Application is a continuation patent application of and claims priority to (i) U.S. Design Patent Application No. 29/567,775, filed on June 13, 2016, entitled PLUSH TOY, (ii) U.S. Design Patent Application No. 29/571,254, filed on July 15, 2016, entitled PLUSH TOY, and (iii) U.S. Design Patent Application No. 29/605,235, filed on May 24, 2017, entitled PLUSH TOY (collectively, “the Priority Applications”);

WHEREAS, we previously assigned our interest in the Priority Applications to Spoon & Moon, LLC, a Washington limited liability company, having its principal place of business at 18422 SE 44<sup>th</sup> Lane, Vancouver, Washington 98683, and the assignments were recorded with the United States Patent and Trademark Office at Reel and Frame numbers 038895/0266, 039168/0922, and 042497/0119;

WHEREAS, as set forth in the Exhibit hereto, effective in Delaware on April 24, 2018 and effective in Washington on April 25, 2018, Spoon & Moon, LLC was converted to Slumberkins Inc., a Delaware corporation, having its principal place of business at 18422 SE 44<sup>th</sup> Lane, Vancouver, Washington 98683, and thus Spoon & Moon, LLC and Slumberkins Inc. are one and the same entity; and

WHEREAS, we and Slumberkins Inc. wish to ratify our prior assignments and confirm Slumberkins Inc.’s ownership of the Present Application;



If the serial number and/or filing date of the above-identified patent application are not known or included on this confirmatory assignment at the time of execution, we hereby authorize Slumberkins Inc., and its successors and assigns, to add such serial number and/or filing date hereto.

Further, we agree that we will communicate to Slumberkins Inc., or its representatives, any facts known to us regarding the subject matter of the above-identified patent application, all inventions disclosed therein, and the history thereof, and testify in any legal proceedings, sign all lawful papers, execute all related U.S. and foreign patent applications, execute all lawful documents and any assignment papers to effectuate the purpose of this confirmatory assignment, make all rightful oaths, and generally do everything possible to aid Slumberkins Inc., and its successors and assigns, to obtain and enforce proper protection for the inventions and improvements in the United States, its territories, and in any and all foreign countries.



**ARTICLES OF CONVERSION
