their successors and assigns, as the assignee of the entire right, title and interest in and to the same, for the sole use and benefit of said COMPANIES, their successors and assigns.



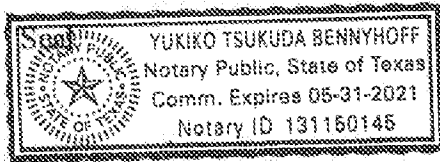

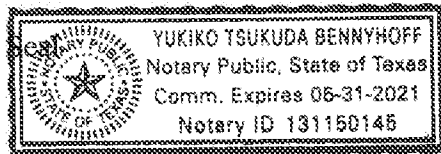
