ASSIGNMENT

WHEREAS, WE, Markus Kuebler, a citizen of Germany residing at Bergwasenstrasse 20, 73312 Geislingen, Germany, Bernd Loos, a citizen of Germany residing at Moerikestrasse 11, 73326 Deggingen, Germany, and Andreas Frank, a citizen of Germany residing at Gustav-Mahler-Weg 11, 89150 Laichingen, Germany, (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled Method for producing a rotor cup for an open-end spinning rotor along with a rotor cup for an open-end spinning rotor, for which an application for Letters Patent of the United States is being concurrently filed in the United States Patent and Trademark Office;



And we hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said

invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE'S full protection and title in and to the invention hereby transferred.




