NOW, THEREFORE, for good and sufficient consideration, the receipt of which is hereby acknowledged, Assignors have sold, assigned, transferred and set over, and by these presents do sell, assign, transfer and set over, unto Assignee, its successors, legal representatives and assigns, the entire right, title and interest in and to the above-mentioned inventions, application for Letters Patent, and in and to any and all direct and indirect divisions, continuations and continuations-in-part of said application, and any and all Letters Patent in the People Republic of China, Hong Kong Special Administrative Region, the European Union, the United States and all countries which may be granted therefore and thereon, and reissues, reexaminations and extensions of said Letters Patent, and all rights under the International Convention for the Protection of Industrial Property, the same to be held and enjoyed by Assignee, for its own use and benefit and the use and benefit of its successors, legal representatives and assigns, to the full end of the term or terms for which Letters Patent may be granted and/or extended, as fully and

entirely as the same would have been held and enjoyed by Assignors, had this sale and assignment not been made.

AND for the same consideration, Assignors hereby represent and warrant to Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, Assignors are the sole and lawful owners of the entire right, title and interest in and to the said inventions and application for Letters Patent above-mentioned, and that the same are unencumbered and that Assignors have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

AND Assignors hereby assign all their rights and interests therein insofar as State Intellectual Property Office of the People's Republic of China is concerned to Assignee, and do hereby authorize Assignee to apply for and obtain Patent rights for the said invention in its own name in State Intellectual Property Office of the People's Republic of China in accordance with this assignment. AND Assignors hereby assign all their rights and interests therein insofar as European Patent Office is concerned to Assignee, and do hereby authorize Assignee to apply for and obtain Patent rights for the said invention in its own name in European Patent Office in accordance with this assignment.
