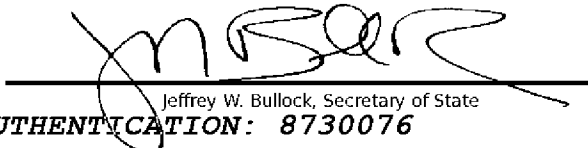

Pursuant to Section 264(c) of the Delaware General Corporation Law (the "DGCL") and Section 18-209 of the Delaware Limited Liability Company Act (the "Act"), the undersigned submits the following Certificate of Merger:

FIRST: The name of the non-surviving entity is Patrick Cudahy, Incorporated, a Delaware corporation, and the name of the surviving entity is Patcud Merger Sub, LLC, a Delaware limited liability company

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with the DGCL and the Act.

THIRD: The new name of the surviving entity (the "Surviving Entity") shall be Patrick Cudahy, LLC, a Delaware limited liability company.

FOURTH: Article 1 of the certificate of formation of the Surviving Entity is hereby deleted in its entirety and substituted in its place is a new Article 1 as follows:

"1. The name of the limited liability company (hereinafter, the "Company") is:

EIGHTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving Entity on request and without cost, to any stockholder or member of any constituent entity.
