patent application, and any U.S. and/or foreign patent applications and/or patents that may be obtained therefore;

AND Assignor hereby authorizes and requests the Commissioner of Patents of the United States Patent & Trademark Office, and any official of any country foreign to the United States whose duty it is to issue patents, to issue any patent and any reissues and extensions thereof to Assignee in accordance with this Assignment;

AND Assignor hereby grants to Assignee the full right in and to all causes of action, in law or equity, for past, present and future infringement of the invention, the patent application, and any U.S. and/or foreign patent applications or patents that may be obtained for the invention, including all rights in and to any profits, damages, and other relief provided thereby, for Assignee's use and behalf and for the use and behalf of Assignee's successors, assigns and other legal representatives;

AND Assignor hereby represents and warrants that Assignor has the full right to convey the entire interest of the invention and the patent application herein assigned and has not granted any rights inconsistent with the rights granted herein.




