STC.UNM furthermore agrees upon request of ASSIGNEES, their successors and assigns, and without further remuneration, to execute any and all papers desired by ASSIGNEES, their successors and assigns, for the filing and granting of the applications/patents hereunder and the perfecting of title thereto in ASSIGNEES, their successors and assigns.
