DECREE
**Decree No. 2015-1132 dated September 11, 2015 Regarding the Creation of Grenoble
Alpes University**

Concerned Public: Grenoble Alpes Users and Personnel.

Purpose: A merger of three Grenoble universities into a single, all-inclusive university based on the principal of Article L. 718-6 of the Education Code, beginning from January 1, 2016. Experimentation based on a temporary process consisting of the election of representatives consisting of research-professors, and similar personnel, to the board of directors and the academic council.

Date of Effectivity: The text becomes applicable the day after its publication. Nevertheless, articles 2, 5, 11 and 12 become effective on January 1 2016.

Note: Grenoble Alpes University is a public institution which has a scientific, cultural and professional nature, and is subject to the provisions of the Education Code and texts taken for its application. Temporary provisions govern the modalities for the constitution of Grenoble Alpes University governing bodies. The property, rights and obligations of Grenoble-I, Grenoble-II and Grenoble-III were transferred to Grenoble Alpes University on January 1 2016.

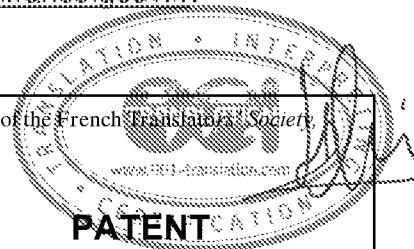
Article L. 711-4 permits an experimental governance, for a duration of five years, that has been adapted to the context of the merger of the universities located on the Grenoble site and includes the academic council and modalities for the constitution of lists of candidates for the election to the board of directors.

The name and statutes of the community of "Grenoble Alpes University" universities and institutions were modified to reflect the merger of the three universities.

Decrees:

Chapter I: General Provisions

Article 1

Grenoble Alpes University is a public institution with a scientific, cultural and professional nature, constituted in the form of a university in the sense of Article L. 711-2 of the Education Code, and subject to the provisions of the same code and texts taken for its application under reservation of the exemptions specified by application of Article L. 711-4 of the same code.

Article 2

Grenoble Alpes University exercises all of the activities that were previously exercised by Grenoble-I, Grenoble-II and Grenoble-III universities which it now envelopes.

Article 3

By exemption to Article L. 719-1 of the Education Code, for the election of representatives consisting of research-professors, and similar personnel, teachers and researchers, to the board of directors, representation of at least three of the main training sectors indicated in Article L. 712-4 of the Education Code is provided by complete lists, alternately composed of two candidates from the sciences and technologies education sector, or the health education sector, or both of these sectors, and two candidates from the legal economic and management education sector, or the letters and human and social sciences education sector, or both of these two sectors.

Article 4

By exemption to the first paragraph of articles L. 712-5 and L. 712-6 of the Education Code, the research commission and the commission of education and university life of the Grenoble Alpes University academic council, include fifty-two members whose composition is determined by the institution’s statutes.

Chapter II: Temporary and Permanent Provisions

Article 5

The property, rights and obligations, including the employment contracts of Grenoble-I, Grenoble-II and Grenoble-III universities, were transferred to Grenoble Alpes University.

The employees previously assigned to these institutions are now assigned to Grenoble Alpes University.

The students registered in Grenoble-I, Grenoble-II and Grenoble-III universities are now registered in Grenoble Alpes University.

Article 6

Within Grenoble Alpes University, a temporary assembly has been constituted from the members of the boards of directors of the Grenoble-I, Grenoble-II and Grenoble-III universities.

The acting presidents of the Grenoble-I, Grenoble-II and Grenoble-III universities are ex officio members of the temporary assembly with voting rights.

Until the installation of the governing bodies specified in Article L. 712-1 of the Education Code, that assembly exercises all of the powers of these bodies.

In accordance with the conditions specified in Article L. 711-7 of the Education Code, it establishes the statutes of the institution which are also sent to the minister in charge of higher learning, within a period of three months beginning from publication of the present decree.

If the Grenoble Alpes University statutes are not established within that period, they shall be established by the minister in charge of higher learning.

Article 7

Until election of the Grenoble Alpes University president in accordance with the conditions specified in Article L. 712-2 of the Education Code, the institution's presidency shall be provided by the Grenoble academic dean, university chancellor.

The Grenoble academic dean, university chancellor, shall exercise the powers assigned to the university president by the same article.

He shall convoke and preside over the temporary assembly and, before December 31, 2015, he shall organise an election for the various institution councils. In accordance with the conditions established in articles D. 719-2 to D. 719-40 of the Education Code, the staff and users of Grenoble-I, Grenoble-II and Grenoble-III universities are both voters and eligible candidates.

Article 8

The councils and directors of boards and common services of the Grenoble-I, Grenoble-II and Grenoble-III universities shall remain in office and continue to exercise their roles until installation of the new councils and nomination or election of the new directors of boards and common services created within Grenoble Alpes University.

Article 9

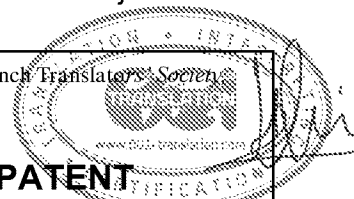
The 2015 accounting period financial accounts of the Grenoble-I, Grenoble-II and Grenoble-III universities period shall be established by accounting agents in charge at the time each university is transferred. They shall be reviewed by the Grenoble Alpes University board of directors.

For the year 2016, the temporary assembly shall determine the Grenoble Alpes University budget which shall be prepared by the Grenoble academic dean, university chancellor.

Article 10

The staff of Grenoble-I, Grenoble-II and Grenoble-III universities are both voters and eligible candidates for the constitution of the technical committee, the institution's joint commission and the Grenoble Alpes University's joint commission.

Until installation of the Grenoble Alpes University technical committee, constituted in accordance with the aforementioned decree dated February 15, 2011, this instance is composed of representatives of the university and the technical committees of the Grenoble-I, Grenoble-II and Grenoble-III universities.

Until installation of the institution's joint commission and the Grenoble Alpes University joint commission, constituted in accordance with the aforementioned decrees dated January 17, 1986, and April 6, 1999, these joint instances shall be composed of representatives of the university and representatives of the institution's joint commissions and the joint commissions of the Grenoble-I, Grenoble-II and Grenoble-III universities.

The Grenoble academic dean, university chancellor, shall convoke and preside over these instances. He shall chair the institution's joint commission and the consulting joint commission with a voting right as an ex officio member.

Article 11

Section I of Article D. 711-1 is modified as follows:

- 1° The words: "22° Grenoble-I;" "23° Grenoble-II;" and "24° Grenoble-III" are deleted;
- 2° The following words: "22° Grenoble Alpes;" are inserted after the words: "21° Evry-Val d'Essonne;"



Article 12

I.-The following are repealed:

- Decree No. 69-729 dated July 18, 1969, concerning election to the temporary assembly of Grenoble-II University;
- Decree No. 69-730 dated July 18, 1969, concerning election to the temporary assembly of Grenoble-III University;
- Decree No. 69-915 dated October 10, 1969, concerning election to the temporary assembly of Grenoble-I University;
- Decree No. 70-452 dated June 1, 1970, concerning erection of the Grenoble-II University, as a public institution with scientific and cultural nature;
- Decree No. 70-578 du 3 July 1970 concerning erection of the Grenoble-III University, as a public institution with scientific and cultural nature.

II.-In Article 1 of Decree No. 70-1174 dated December 17, 1970, concerning the erection of universities and university centres as public institutions with scientific and cultural natures, the following words are deleted: "Grenoble-I,".

III.-In the table appended to the decree dated December 23, 1970, concerning the erection of teaching and research units as public institutions with scientific and cultural natures, the following row is deleted:

Article 13

I. – In the title and in articles 1 and 2 of the aforementioned decree dated December 29, 2014, the following words: “Grenoble Alpes University” are replaced by the following words: “Grenoble Alpes Community University”.

II. – The modifications to the appendix of the aforementioned decree dated December 29, 2014, indicated in the appendix to the present decree are approved.

Article 14

Articles 2, 5, 11, 12 become effective on January 1, 2016.

Article 15

The Minister of National Education, Higher Learning and Research, the Minister of Finance and Public Accounts, the Secretary of the State in charge of higher learning and research and the Secretary of the State in charge of the budget, are in charge, each according to their assignment, for the execution of the present decree, which will be published in the Official Journal of the French Republic.

APPENDIX

I. – The Grenoble Alpes University statutes are modified as follows:

1° In the title of the appendix and in articles 5 and 30, the following words: “the Grenoble Alpes University” are replaced by the following words: “the Grenoble Alpes Community University”;

2° In Article 1, the following words: “Grenoble Alpes University” are replaced by the following words: “the Grenoble Alpes Community University” and in the second-last paragraph of Article 19, the following words: “the Grenoble Alpes University” are replaced by the following words: “the Grenoble Alpes Community University”;

3° In the first paragraph of Article 2, the following words: “Upon institution of the present statutes” are deleted;

4° In the third paragraph of Article 2, the following words: “Joseph Fourier, Grenoble I” are replaced by the following words: “Grenoble Alpes” and the fourth and fifth paragraphs are deleted;



5° In the tenth paragraph of Article 2, the number: "37" is replaced by the number: "36";

6° In the second paragraph of Article 11, the following words: "each member, designated by the institutions of higher learning or" are replaced by the following words: "the Grenoble Polytechnic Institute, three representatives for Grenoble Alpes University and one representative for each of the";

7° In the seventh paragraph of Article 19, the following words: "Each institute of higher learning shall name a representative," are replaced by the following words: "The Grenoble Polytechnic Institute shall name a representative, Grenoble Alpes University shall name three representatives,";

8° In the fourteenth paragraph of Article 19, the following words: "Seventeen for the Joseph Fourier Grenoble-I University, of which twelve, two and three" are replaced by the following words: "Forty-two for the Grenoble Alpes University, of which twenty-eight, six and eight";

9° The fifteenth and sixteenth paragraphs of Article 19 are deleted;

10° In Article 30, the numbers: "6°, 7°, 8°, 9°, 10°, 11° and 12°" are replaced by the numbers: "4°, 5°, 6°, 7°, 8°, 9° and 10°";

11° In the second paragraph of Article 35, the acronym: "UGA" is deleted;

12° In the fifth and sixth paragraphs of Article 35, the following words: "article 20" are replaced by the following words: "article 19".

II. – The modifications made to 3°, 4°, 6°, 7°, 8° and 9° shall take effect on January 1, 2016.
