which may be necessary in order to carry into full force and effect and to record the sale, assignment and transfer hereby made or intended to be made herein and the ASSIGNOR covenants that it has the full right to convey the entire right, title and interest hereby assigned or intended to be assigned and that it has not executed and will not execute any agreement or take any action in conflict herewith.
