WHEREAS, Assignor owns the entire right, title and interest to U.S. Patent Application No. 13/530,769, entitled "Accurate Measurement of Glutathione for Disease Diagnosis and Drug Metabolite Screening," Published as U.S. Published Patent Application No. 20130158886.

- (d) The Invention and Patent are believed not to infringe the rights of any person or entity;
- (e) There are no known claims, pending or threatened, with respect to Assignor's rights in the Invention and Patent; and
- (f) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

**4. Entire Agreement.** This Agreement, contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof.

**5.
