(the "**Assignor**"), a company organized and existing under the laws of British Columbia, Canada, and having an address at 3300 Pleasant Street, Richmond, British Columbia, Canada, V7E 2P4, is the owner of certain inventions or improvements (the "**Inventions**") described and/or claimed in PCT patent application No. PCT/US2015/026049 filed 16 April 2015, entitled EQUIPMENT ORGANIZER; and United States patent application No. 15304244 filed 14 October 2016, entitled EQUIPMENT ORGANIZER (individually and collectively, the "**Applications**"), and is the owner of the design mark STORAGE DEVICE DESIGN (the "**Trade Dress**"), which is the subject of Canadian Trademark Application No. 1801253 filed 20 September 2016 (the "**Trademark**") (individually and collectively, the "**Intellectual Property**");

WHEREAS, Clug Brands, Inc. (the "**Licensee**"), a company organized and existing under the laws of British Columbia, Canada, and having an address at 3300 Pleasant Street, Richmond, British Columbia, Canada, V7E 2P4, is a licensee of the Intellectual Property from the Assignor under a Technology License Agreement (the "**License**") made between them and dated the 20th day of April, 2017.

WHEREAS, the Assignor wishes to sell all of the Assignor's right, title, and interest in and to the Intellectual Property and all of their associated goodwill to Bullet Ventures Limited (the "**Assignee**"), a corporation organized and existing under the laws of England, and whose head office is at The Hornits' Nest, 45 Denmark Road, Exeter, United Kingdom, EX1 1SQ, and the Assignee is desirous of acquiring all right, title, and interest in and to the Intellectual Property and all of their associated goodwill;

NOW THEREFORE, for the sum of CAD \$10.00 and other good and valuable consideration, including the execution of the Purchase Agreement by the Assignor and the Assignee, the Assignor hereby sells, assigns, transfers, and sets over to the Assignee the entire worldwide right, title, and interest in and to:

- the Intellectual Property;
- any application(s), registration(s) or renewal(s) pertaining to the Trade Dress;
- all national phase applications arising from the Applications;
- all continuations, divisions, renewals of, or substitutes for the Applications;
- the right to file counterparts to the Applications in all countries and regions;
- the right to claim priority from the Applications in all countries and regions;
- each and every additional application that claims any part of the Inventions;
- each and every additional application that is in any way based on or claims priority from or corresponds to the Applications;
- all patents which may be granted on or as a result thereof;
- any reissue or reissues of such patents; and
- all causes of action and rights to bring suit for past, present, and future infringement of rights in the Intellectual Property, and all claims for and rights to collect damages, profits, and all other remedies and relief in respect thereof, including other compensation in respect of pre-grant activities;

free and clear of all liens, charges and encumbrances whatsoever, save and except for the License, the same to be owned by the Assignee, its successors, assigns, nominees, or legal


representatives, for the full term or terms of the patents entirely as the same would have been owned by the Assignor, had this Assignment, sale, and transfer not been made.


