INTELLECTUAL PROPERTY ASSET ASSIGNMENT

WHEREAS, Dan Ariel Zlotolow, Raymond B. Raven, Jonathan L. NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, each Assignor individually and the Assignors collectively hereby sells, assigns, transfers and conveys unto Assignee the entire right, title and interest of such Assignor in and to said Assets including any patent applications, divisions, renewals and continuations thereof, and any and all Letters Patent of the United States which may be granted thereon, and all reissues, reexaminations, and extensions thereof, and all priority rights under all available international agreements, treaties and conventions for the protection of intellectual property in its various forms in every participating country, and all applications for Letters Patent or other grants of protection of proprietary rights including, but not limited to, inventor's certificate, utility model, utility certificate, patent of importation, registration of patent and industrial design registration which may be filed, and which may be granted, upon said Assets in any countries or regions foreign to the United States, and all reissues, renewals and extensions thereof; and Assignor hereby authorizes and requests the Commissioner for Patents and Trademarks of the United States, and all officials of countries or regions foreign to the United States having authority so to do, to issue all such Letters Patent or other grants of protection upon said Assets to the Assignee or to such nominees as it may designate;

AND Assignor hereby authorizes and empowers the Assignee or nominees to invoke and claim for any application for such Letters Patent or other grants of protection for said Assets filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by a convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from such Assignor;

AND Assignor hereby consents that a copy of this Assignment shall be deemed a full and formal equivalent of any assignment, consent to file or like document which may be required in any country or region for any purpose and more particularly in proof of the right of the Assignee or nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it;

AND Assignor hereby covenants that such Assignor has the full right to convey the right, title and interest in said Assets, that such Assignor has not executed and will not execute any agreement in conflict herewith, that such Assignor has not made any assignment of any invention(s), application(s), or patent(s) in the Assets to a party other than Assignee in conflict herewith; and that such Assignor has no obligation to make any assignment of any invention(s), application(s), or patent(s) in the Assets to any party other than Assignee;

AND Assignor hereby covenants and agrees that such Assignor will communicate to Assignee or nominees all facts known to such Assignor pertaining to the Assets, and testify in all legal proceedings, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and declarations and in general perform all lawful acts necessary or proper to aid Assignee or nominee in obtaining, maintaining and enforcing all lawful patent or other grants of protection of the Assets in any and all countries and regions.

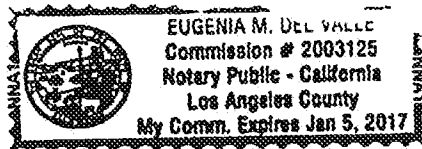

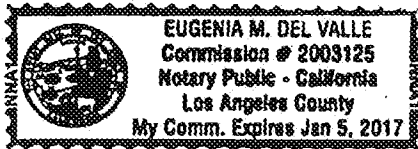


