OF POWERED DEVICE(S) ON A VEHICLE WITH DIRECT CHARGING**

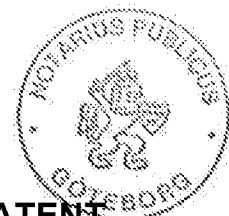
