NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor agrees as follows:

1. Assignor does hereby sell, transfer, convey, assign, grant, set over and deliver to Assignee, all of Assignor's right, title, and interest in and to the Assigned Intellectual Property, and in and to any and all reissues, reexaminations or extensions of the Assigned Intellectual Property, and all foreign countries which may be granted therefor and thereon, and in and to any and all divisions, continuations, and continuations-in-part, and all rights under the International Convention for the Protection of Industrial Property, free and clear of all Liens, the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, designees, nominees and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made, together with (i) all causes of action (in law or equity) claims, demands and any other rights for, or arising from, any past or future infringement, of the Assigned Intellectual Property, and (ii) the right to sue for and collect any past and future damages for the use and benefit of Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives.

2. Assignor hereby covenants and agrees to and with the said Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, the said Assignor is the sole and lawful owners of the entire right, title and interest in and to the Assigned Intellectual Property, and that the same are unencumbered and that the said Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth.





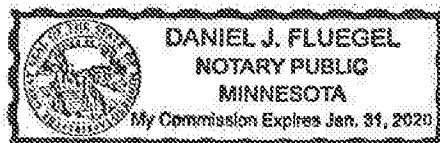
