## RELEASE OF PATENT SECURITY AGREEMENT

This Release of Patent Security Agreement (the "**Release**") is made and effective as of June 29, 2018 and granted by Brookside Mezzanine Partners III, L.P., (the "**Agent**"), in its capacity as agent for the Lenders (as defined in the Patent Security Agreement described below) and in favor of Surface Preparation Technologies, LLC, a Pennsylvania limited liability company (the "**Grantor**").

**WHEREAS**, the Grantor collaterally assigned to the Agent a security interest in all of Grantor's right, title and interest in, to and under the patents identified in Schedule A attached hereto (the "**Intellectual Property**") pursuant to that certain Patent Security Agreement dated as of February 10, 2017 made by Grantor in favor of Agent (the "**Patent Security Agreement**"; capitalized terms used, but not defined herein shall have the meaning ascribed to such term in the Patent Security Agreement) which such Patent Security Agreement was recorded with the United States Patent and Trademark Office on February 17, 2017 at Reel/Frame 041273/0492.

**WHEREAS**, the Agent has agreed to release its security interest in the Intellectual Property and terminate such Patent Security Agreement.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Release of Patent Security Interest. Agent hereby terminates the Patent Security Agreement and terminates, releases and discharges any and all security interests or lien that it has pursuant to the Patent Security Agreement in any and all right, title and interest of the Grantor under the following (collectively, the "Patent Collateral"):

- a. All of Grantor's Patents, including those referred to on Schedule A hereto;
- b. all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations of and amendments to the foregoing;
- c. all rights of any kind whatsoever of Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
- d. any and all royalties, fees, income, payments, products and other proceeds now or hereafter due or payable with respect to any of the foregoing; and
- e. any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuses, breach or default, with the right but no obligation to sue for such legal and equitable relief to collect, or otherwise recover, any such damages.

2. Reassignment and Authorization. Agent hereby reassigns, grants and conveys to Grantor, any and all of Agent's right, title and interest in and to the Patent Collateral, and authorizes the recordation of this Release with the United States Patent and Trademark Office at the expense of the Grantor.

3. Further Assurances. Agent agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


