- (f) all priority rights foreign and domestic resulting from the above identified patent application.

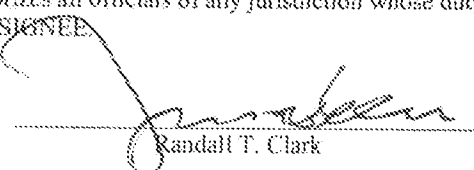

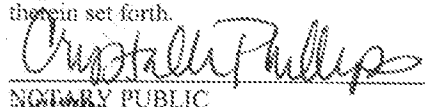
