

























TITLE

Grill for a microwave oven

The following is a specification, reference being made to the accompanying drawings that form a part thereof.

SPECIFICATION

The grill of my invention may be introduced into a microwave oven with food items pressed between cooking plates of the grill. When the microwave oven is switched on,

the emitted microwaves heat up the cooking plates that cook the food items.

Description of the Drawings

Fig. 1 is an exploded perspective view of the grill for microwave oven consisting

of two separable identical grill plate assemblies and two separable identical elastic retainers. The non-shown lower side of the upper grill plate assembly is identical to the shown upper side of the lower grill plate assembly and the non-shown lower side of the lower elastic retainer is identical to the shown upper

side of the elastic retainer.

Fig. 2 is a perspective view of the grill for microwave oven in a position previous

to use.

Fig. 3 is a perspective view of the grill for microwave oven in a working position.

Fig. 4 is a top view of the grill for microwave oven in the position previous to

use.

Fig. 5 is a bottom view of the grill for microwave oven in the position previous to

use.

Fig. 6 is a front elevation view (symmetrical to the rear elevation view) of the

grill for microwave oven in the position previous to use.

Fig. 7 is a right elevation view (symmetrical to the left elevation view) of the grill


for microwave oven in the position previous to use.
