ASSIGNMENT

THIS ASSIGNMENT is made the 6 day of October 2017

BETWEEN

1. Christian FAGES, a French citizen of Donazac, Saint Felix, 46100 Figeac, France

AND

2. Ratier-Figeac SAS, a French company of B.P. #2, Avenue Ratier, 46101 Figeac, France ("Ratier")

WHEREAS

TO HOLD the same unto Ratier absolutely

2. Ratier shall have the right to file applications for and/or be granted patents, utility models, registered designs, design patents, and any other intellectual property rights in its own name or in the name of the Inventor or in such other name or names as Ratier may desire and the Inventor acknowledges that if any such applications are filed or rights granted in the name of the Inventor the same shall be held in trust by the Inventor for Ratier and shall at the request of Ratier be transferred from the Inventor to Ratier for no further consideration.

3. The Inventor hereby covenants with Ratier if and when required by Ratier to sign execute and do all such further documents acts or things as may be necessary or desirable to enable Ratier to procure and enjoy the full and exclusive benefit of the Invention(s) and of all rights therein including patents, design patents, registered designs, utility models or other intellectual property rights in any country of the world including if required the execution of further assignments by way of confirmation of this assignment and the execution of documents in connection with applications for patents, utility models, registered designs, design patents or any other intellectual property rights in the Inventor's own name in respect of the United States of America or any other country.
