**ASSIGNMENT**

THIS ASSIGNMENT is made the 29 day of August 2017

BETWEEN

1. Christian FAGES, a French citizen of Donzac, Saint Felix, 46100 Figeac, France

AND

2. Ratier-Figeac SAS, a French company of B.P. #2, Avenue Ratier, 46101 Figeac, France ("Ratier")

**WHEREAS**

(ii) The right to claim priority under any national, regional or international law or treaty from the Patent Application or from any other Application for intellectual property rights in respect of the Invention(s)


TO HOLD the same unto Ratier absolutely

The Inventor hereby covenants with Ratier if and when required by Ratier to sign execute and do all such further documents acts or things as may be necessary or desirable to enable Ratier to procure and enjoy the full and exclusive benefit of the Invention(s) and of all rights therein including patents, design patents, registered designs, utility models or other intellectual property rights in any country of the world including if required the execution of further assignments by way of confirmation of this assignment and the execution of documents in connection with applications for patents, utility models, registered designs, design patents or any other intellectual property rights in the Inventor's own name in respect of the United States of America or any other country.
