

AND I HEREBY FURTHER covenant and agree that this Assignment is effective as of 18 November 2014.

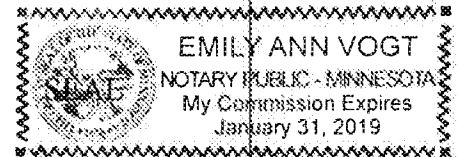
