C. Binding, Complete and Enforceable Agreement

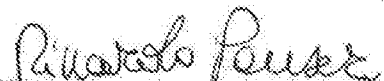

D. Execution

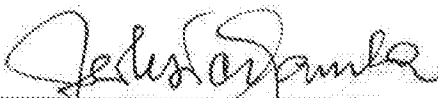

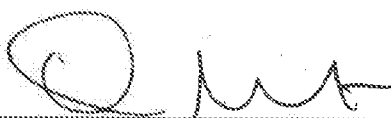
