The Parties hereby acknowledge and agree that Assignor was the owner of United States Patent No. 8,915,996 entitled **LOW DUST, LIGHT WEIGHT FILLER COMPOSITION**, issued December 23, 2014 (the "Invention") and that Assignor sold, assigned, transferred, and set over its entire right, title, and interest, in and throughout the United States of America (including its territories and dependencies) and all countries foreign thereto, in and to said Invention and in and to any applications that may be filed or any patents that may be granted for said Invention, including any divisional, continuation, continuation-in-part, reissue, or other patent application based on the Invention, anywhere in the world to Assignee pursuant to that certain Assignment executed on January 17, 2017, recorded on January 20, 2017, Reel/Frame 041027/0510 (the "Original Assignment"); and

2. Assignor hereby confirms that, pursuant to the Original Assignment, it has sold, assigned, transferred, and set over unto Assignee the entire right, title, and interest, in and throughout the United States of America (including its territories and dependencies) and all countries foreign thereto, in and to said Invention and in and to any applications that may be filed or any patents that may be granted for said Invention, including any divisional, continuation, continuation-in-part, reissue, or other patent application based on the Invention, anywhere in the world, including United States Patent No. 9,217,072 entitled **LOW DUST, LIGHT WEIGHT FILLER COMPOSITION**, issued December 22, 2014 (the "Division").

3. The Parties hereby acknowledge, agree, and confirm that effective as of the date originally signed by Assignor in the Original Assignment and for valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged by the Parties, Assignor did sell, assign, transfer and set over to Assignee and did thereby and (to the extent that Assignor has not sold, assigned, transferred, or set over) does hereby sell, assign, transfer and set over *nunc pro tunc* to Assignee, the entire right, title and interest in and to the Invention and the Division, collectively, together with any and all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement.

4. Assignor represents, warrants and covenants that, at the time of execution and delivery of the Original Assignment, Assignor was the sole and lawful owner of the entire right, title and interest in and to the Invention and the Division, and that the same were unencumbered and that Assignor had good and full right and lawful authority to sell and convey the same in the manner set forth in this Assignment.

5. This Assignment is binding upon and will inure to the benefit of the parties and their respective successors and permitted assigns. This Assignment may be executed in counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement.

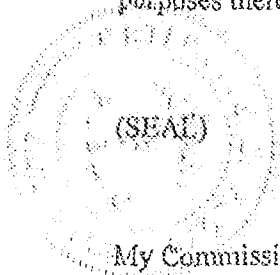


