

CONFIRMATORY ASSIGNMENT

NOW, THEREFORE, and further in view of the aforementioned valuable and legally sufficient consideration, the Assignors do hereby confirm having made the above-referenced Assignment prior to September 8, 2017, and to the extent that such Employment Agreement is deemed insufficient to have effected such transfer, sale and assignment, does hereby transfer, sell and assign to Assignee, effective prior to September 8, 2017, the entire right, title and interest for the United States in and to the invention and the patent applications identified above, and any patents that may issue for said invention in the United States; together with the entire right, title and interest in and to said invention and all patent applications and patents issuing therefrom in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; together with the entire right, title and interest in and to all continuations, divisions, renewals and extensions of any of the patent applications and patents defined above; together with the right to recover all damages, including, but not limited to, a reasonable royalty, by reason of past, present, or future infringement or any other violation of patent or patent application rights; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.
