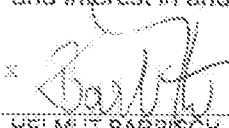

as described and claimed in patent application No. 15/984,842, filed May 21, 2018;

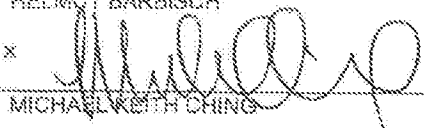
