DEED OF ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

PARTIES

INTRODUCTION

1. The Assignor has agreed to assign the patents/patent applications listed in Appendix A (Intellectual Property Rights) to the Assignee upon the terms of this deed.

AGREED THAT:

1. COVENANTS

 - (b) all rights (whether in the name of either Assignor or the Assignee) to bring or defend any claim or proceedings in relation to the Intellectual Property Rights, including any such rights which may have accrued before the signing of this deed.
- 1.2. **Further Assurances.** Upon request and at the Assignee's cost, the Assignor will execute all documents and perform any other acts that may be necessary or desirable to perfect or confirm the Assignee's ownership of the Intellectual Property Rights, assist the Assignee to defend or enforce its ownership of the Intellectual Property Rights, and otherwise give effect to the intent of this deed.

2. GENERAL

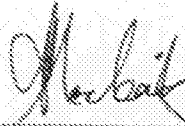

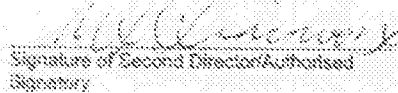

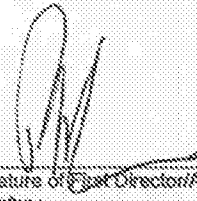
