PATENT ASSIGNMENT

OLYMPUS MEMORY WORKS CORP., a Japanese corporation, having a principal place of business at 3-1, Nishi-Shinjuku 2-chome, Shinjuku-ku, Tokyo 163-0914, Japan and OLYMPUS CORPORATION, a Japanese corporation having a principal place of business at 2951 Ishikawa-machi, Hachioji-shi, Tokyo 192-8507 (collectively referred to herein as the "PARTIES"), are joint owners by assignment of the entire right, title and interest in United States Patent Application Serial Number 15/635,849, filed on June 28, 2017, and entitled IMAGE RETRIEVAL APPARATUS (herein after referred to as the "INVENTION").

For good and valuable consideration, the receipt and sufficiency of which is acknowledged, OLYMPUS MEMORY WORKS CORP., intending to be legally bound, does hereby sell, assign and transfer to OLYMPUS CORPORATION and OLYMPUS CORPORATION's successors, assigns and legal representatives its entire right, title and interest, legal and equitable, in the INVENTION and all patent applications thereon, including, but not limited to, the application for United States Letters Patent entitled as above, and all divisions and continuations thereof, and in all letters patent, including all reissues and reexaminations thereof, throughout the world, including the right to claim priority under the Paris Convention or other treaty.

It is agreed that the OLYMPUS MEMORY WORKS CORP. shall, upon request of the OLYMPUS CORPORATION, execute any additional instruments proper to carry out the intent of this ASSIGNMENT.

OLYMPUS MEMORY WORKS CORP. warrants that the rights and property herein conveyed are free and clear of any encumbrance.

This ASSIGNMENT may be executed in multiple counterparts, each of which shall be deemed to be an original of this ASSIGNMENT. Additionally, the PARTIES authorize their representatives to collect the signature pages of each executed counterpart and to attach those signature pages to a single copy of this instrument, which single copy and attached signature pages together shall constitute an original of this ASSIGNMENT.
