

lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and do everything possible to aid UNIVERSITY OF PITTSBURGH -- OF THE COMMONWEALTH SYSTEM OF HIGHER EDUCATION, its successors, and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.



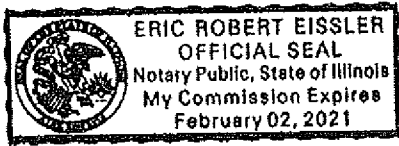
