TERMINATION AND RELEASE OF
SECURITY AGREEMENT (INTELLECTUAL PROPERTY)

This TERMINATION AND RELEASE OF SECURITY AGREEMENT (INTELLECTUAL PROPERTY) (this "Termination"), dated as of July 11, 2018, is executed by Bearcub Acquisitions LLC, a Delaware limited liability company ("Lender"), in favor of ChargePoint, Inc., a Delaware corporation ("Debtor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Security Agreement (Intellectual Property), dated as of December 24, 2014 (the "Security Agreement"), by and between Debtor and Ares Capital Corporation, Debtor granted to Lender a security interest in the Collateral (defined below).

B. Lender hereby represents and warrants that (a) Ares Capital Corporation assigned such Security Agreement and all its rights and interests thereunder, including all rights and interests regarding the Collateral, to Lender (the "Assignment"), (b) Lender continues to hold all such rights and interest and (c) neither Ares Capital Corporation nor any third party has any right or interest in, to, under or regarding the Security Agreement or Collateral.

C. The Assignment was recorded with the Patent Division of the United States Patent and Trademark Office on December 21, 2017, at Reel/Frame 044442/0781, to evidence the security interest granted under the Security Agreement (the "Recordation").

D. Lender agrees to execute this Termination in order to evidence the termination and release of any rights under or relating to the subject matter of the Security Agreement, including without limitation, any interest the Collateral.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby agrees as follows:

(a) Lender hereby expressly terminates and releases, and assigns to Debtor any and all of Lender's right, title and interest in, to, under or regarding the Security Agreement and the Collateral.

(b) Lender will promptly execute any other documents and take any other actions requested by Debtor to more fully evidence, effect, perfect, accomplish and record the such termination, release and assignment, to reverse the effect of the Recordation, and to otherwise accomplish the purpose and intent of this Agreement.


(c) Lender represents and warrants that it has the full power and authority to execute and perform this Termination.

(d) Lender authorizes and requests the patent and trademark divisions of the United States Patent and Trademark Office, and the United States Copyright Office, to record this Termination.
