**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("Assignment"), is made as of the 22nd day of May, 2018, by and between Elligo Health Research, Inc., a Delaware corporation ("Buyer") and ePatientFinder, Inc., a Delaware corporation ("Seller")

**R E C I T A L**

Pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement") dated as of May 22, 2018 by and among the Buyer and the Seller, Seller has conveyed, transferred and assigned to Buyer all Intellectual Property used in or related to the Business of Seller (the "Assigned IP") and has agreed to execute and deliver this Assignment.

**A G R E E M E N T S**

NOW, THEREFORE, pursuant to the Purchase Agreement and in consideration of the recitals, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1. Transfer of Assigned IP. As of the Effective Time, upon the terms and subject to the conditions contained in the Purchase Agreement, Seller does hereby irrevocably convey, transfer and assign to Buyer, and Buyer hereby accepts, all of Seller's right, title and interest in and to the Assigned IP, including all of Assignor's right, title and interest, whether statutory or at common law, in and to all trademarks, trademark applications, and trademark registrations and all patents and patent applications set forth on **Exhibit A**, attached hereto, together with all related common law rights and the goodwill of the Business connected with the use of and symbolized by the Assigned IP, in the United States of America and throughout the world, and in and to all legal equivalents of the Assigned IP in foreign countries to the extent any such rights exist in foreign countries.

2. Filings; Further Assurances. Seller authorizes the appropriate governmental officials to record and register this Assignment upon request by Buyer. Seller, at Buyer's expense, shall take such steps and actions following the date hereof, including the execution and delivery of any documents, files, registrations, affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other similar items, as may be necessary to effect, evidence or perfect the assignment of the Assigned IP to Buyer, or any assignee or successor thereto.

3. Purchase Agreement. This Assignment is subject in all respects to the terms and conditions of the Purchase Agreement. All capitalized terms used herein and not defined herein will have the meanings set forth in the Purchase Agreement.

4. Effective Time. The effective time of this Assignment is the Effective Time under the Purchase Agreement.

5. Counterparts; Electronic Delivery. This Assignment may be executed in any number of counterparts with the same effect as if each of the parties hereto had signed the same document. All counterparts shall be construed together and shall constitute one Assignment. This Assignment, to the extent signed and delivered by means of a facsimile machine or via e-mail,

shall be treated in all manner and respects as an original agreement or instrument and shall be considered to have the same binding legal effect as if it were the original signed version thereof delivered in person.
