## RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN PATENTS (this "Release") is made effective as of February 22, 2017, by U.S. Bank National Association, a national banking association (the "Secured Party") for itself and as administrative agent for the Lenders (as defined in the Credit Agreement referenced below) in favor of Skip Hop, Inc., a New York corporation (the "Company").

WHEREAS, the Company, Skip Hop Holdings, Inc., a Delaware corporation, the lenders party thereto (the "Lenders"), and the Secured Party, as one of the Lenders, swing line lender, administrative agent for the Lenders, and letter of credit issuer (in such capacity, the "Agent"), are all parties to a Credit Agreement dated as of November 22, 2013, as amended by that certain Waiver and First Amendment to Credit Agreement dated as of July 23, 2015, that certain Consent and Second Amendment to Credit Agreement dated as of June 3, 2016, and that certain Third Amendment to Credit Agreement dated as of January 11, 2017 (as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") pursuant to which the Lenders agreed to extend to the Company certain credit accommodations;

WHEREAS, the Company has granted security interests to the Secured Party under the Pledge and Security Agreement and Irrevocable Proxy dated as of November 22, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Company executed and delivered a Confirmatory Grant of Security Interest in Patents dated as of November 22, 2013 (the "Confirmatory Grant") granting the Secured Party, among other collateral as set forth therein, a security interest in and lien on the patents identified on Exhibit A hereto (the "Patent Collateral");

WHEREAS, the Confirmatory Grant was recorded with the United States Patent and Trademark Office against the Patent Collateral on November 22, 2013 at Reel number 031712 and Frame number 0371; and

WHEREAS, the Company has satisfied all of the Obligations under the Credit Agreement and the Security Agreement and has requested that the Secured Party terminate and release its security interests in and liens on the Patent Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement, the Security Agreement, or the Confirmatory Grant, as the case may be.


2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the Patent Collateral,

including, without limitation, the patents listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Company, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such patents, effective as of the date set forth above.
