WHEREAS, the Assignor, an organization of the Republic of Korea, owns the patent and/or patent application as defined in Appendix 1 (the "Patent").

WHEREAS, the Assignee is an individual residing at the address identified above.

WHEREAS, the Assignor agrees to assign the "Patent" to the Assignee and the Assignee agrees to accept the assignment of the "Patent".

NOW, THEREFORE, through mutual negotiation, the parties hereto agree as follows:

1. Transfer of the "Patent"

The Assignor agrees to transfer and change the ownership of the "Patent" to the Assignee and the Assignee agrees to obtain the ownership of the "Patent". The Assignee shall pay the Assignor an amount of US\$ 350 for the "Patent" transferred hereunder.

2. Recordation/Registration Fees

The recordation/ registration for the change of the ownership of the "Patent" shall be undertaken by the Assignor and the Assignor shall bear the recordation/registration fees incurred hereby.

3. Representations and Warranties

3.1 The Assignor hereby represents and warrants as follows:

3.1.1 the Assignor has the exclusive ownership of the "Patent" and no rights or equity of any third party is prejudiced due to the using of he "Patent". There is no litigation or any other disputes arising from or relating to the "Patent".

3.1.2 the Assignor, has taken necessary steps and obtained full authority and all consents and approvals of any other third party and governmental necessary to execute and perform this Agreement, which shall not be against any enforceable and effective laws or contracts..

3.1.3 Once this Agreement has been duly executed by both parties, it will constitute a legal, valid and binding agreement of the Assignor enforceable against it in accordance with its terms upon its execution.

3.1.4 the Assignor will not engage in any action that will be detrimental to the validity of the "Patent" after the completion of the assignment.

3.2 The Assignee hereby represents and warrants as follows:

3.2.1 The Assignee is an individual residing at the address identified above.

3.2.2 The Assignee, subject to its business scope and corporate power, has taken necessary steps and obtained full authority and all consents and approvals of any other third party and governmental necessary to execute and perform this Agreement, which shall not be against any enforceable and effective laws or contracts.

3.2.3 Once this Agreement has been duly executed by both parties, it will constitute a legal, valid and binding agreement of the Assignee enforceable against it in accordance with its terms.

4. Effective Date and Term

The Appendices referred to in this Agreement are an integral part of this Agreement and have the same legal effect as this Agreement.




