THIS ASSIGNMENT is effective the December 21, 2015 and is made between

(hereinafter referred to as **MCOR**) of the second part and

WHEREAS

(a) The inventors have made certain inventions or discoveries (or both) set forth in an application for Letters Patent and relating to "*Theta Wheel*"; to be filed at the GB patent office;

(b) The Inventors are, or were at the time the inventions was made, employees of the MCOR or were under contractual obligation with MCOR, and made the said inventions and/or discoveries in the course of carrying out their duties as such employee or contractual duties;

NOW THIS DEED WITNESSETH that in consideration of the premises and of the sum of Ten Euro (€10) the receipt of which is hereby acknowledged and without reservations:

1. The Inventors hereby assigns, transfers and conveys unto MCOR the entire right and title and interest in and to the said inventions and/or discoveries, the said application for Letters Patent and any and all other applications for Letters Patent or otherwise on the said inventions and/or discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation applications and applications under the International (Paris) Convention, European Patent Convention, Patent Cooperation Treaty, Community Patent Convention, or otherwise, based in whole or in part upon said inventions and/or discoveries, or upon the said application, and in and to any and all Letters Patent, reissues and extensions of Letters Patent granted for said inventions and/or discoveries or upon the said application, and every priority right that is or may be predicated upon or arise from said inventions and/or discoveries, said application and Letters Patent;

2. The Inventors hereby authorizes MCOR to file and assents to the MCOR filing patent applications in any or all countries on any or all of said inventions and/or discoveries in the name of the Inventors or in the name of MCOR or otherwise as MCOR may deem advisable, under the terms of the International (Paris) Convention, European Patent Convention, Patent Cooperation Treaty, Community Patent Convention or otherwise;

3. The Inventors hereby warrants that they have not knowingly conveyed to others any right in the said inventions and/or discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions and/or discoveries; and that the Inventor has good right to assign the same unto MCOR without encumbrance;

4. The Inventors hereby bind their heirs, legal representatives and assigns, as well as themselves, to do, upon MCOR's request and at MCOR's expense, but without additional consideration to them or to MCOR, all acts reasonably serving to assure that the said inventions and/or discoveries, the said patent application and the said Letters Patent shall be held and enjoyed by MCOR as fully and entirely as the same could have been held and enjoyed by the Inventor, their heirs, legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to MCOR all lawful application documents including petitions, specifications, oaths, powers of attorney, and all assignments, disclaimers and lawful

affidavits in form and substance as may be required by MCOR's; to communicate to MCOR's all facts known to the Inventor relating to said inventions and/or discoveries or the history thereof; and to furnish MCOR's with any and all documents, photographs, models, samples and other physical exhibits in the Inventor's control or in the control of their heirs, legal representatives or assigns which may be useful for establishing the facts of the conceptions, disclosures, and reduction to practice of said inventions and/or discoveries.

5. The inventors hereby covenant with MCOR's as follows:

- (i) That they will (so far as necessary) permit and enable MCOR to apply For and will take all reasonable steps to assist MCOR in obtaining the grant of patent or like protection in respect of the invention hereinbefore assigned in any territory as may be required by MCOR.
- (ii) That they will at the request and cost of MCOR execute and do all such documents, acts and things as may be necessary for the purpose of subparagraph (i) hereof and for vesting any relevant invention, application for patent, patent, know-how, copyright or design in MCOR absolutely.
- (iii) The Inventors hereby irrevocable appoint MCOR as their Attorney in their name to execute any document and do any acts or thing as may be required to comply with the provisions of clause (i) hereof).
