BE IT KNOWN that for and in consideration of the sum of One Dollar (\$1.00) to me in hand paid by Assignee and other good and valuable consideration, the receipt of which is hereby acknowledged, said Assignor does hereby sell, transfer and assign and have sold, assigned, transferred and set over as of July 16, 2018, unto the said Assignee its entire right, title and interest to said inventions and Patents, the same to be held and enjoyed by Assignee, for its own use and enjoyment, as fully and entirely as the same would have been enjoyed by Assignor had this assignment and sale not been made; together with (i) all of Assignor's interest in improvements thereto and in the Patents issued therefore; (ii) all claims for damages by reason of past infringement of said Patents; and (iii) the right to sue for, collect the same for its own use and behalf, and for the use and behalf of its legal representatives, successors and assigns, to the full end of the term for which said Patents or any reissues, renewals, or extensions as are granted as fully and entirely as the same would have been held by me had this Assignment and sale not been made.

Assignee is hereby authorized to make application for and to receive Letters Patent for said inventions in any foreign country at its election.


