WHEREAS, I, Richard D. Spreen, residing in Fort Lauderdale, Florida have invented certain new and useful inventions and improvements in and to the subject matter of:

**ENVIRONMENTALLY RESPONSIBLE INSULATED CONSTRUCTION BLOCKS**

described in a Patent Cooperation Treaty (PCT) patent application filed on November 17, 2015 and accorded Patent Application No. PCT/US2015/061055 (the "Application");

AND I hereby agree for myself and my heirs, executors and administrators to execute without further consideration any further documents and instruments which may be necessary, lawful and proper in the prosecution of said Application or in the preparation or prosecution of any continuing, substitute, divisional, renewal, reexamination or reissue application or in any amendments, extensions or interference proceedings, or other applications for patents of any region or country, that may be necessary to secure to ASSIGNEE its interest and title in and to said inventions and improvements or any parts thereof, and in and to said several patents or any of them;

AND I hereby covenant for myself and my legal representatives, and agree with said ASSIGNEE, its successors and assigns, that I have granted no right or license to make, use, sell or offer to sell said inventions and improvements, to anyone except said ASSIGNEE, that prior to the execution of this deed, my right, title and interest in said inventions and improvements had not been otherwise encumbered, and that I have not and will not execute any instrument in conflict therewith;

AND in the event the ASSIGNEE is unable, after reasonable effort, to secure my signature on any document relating to the Application, whether because of my physical or mental incapacity or for any other reason whatsoever, I hereby irrevocably designate and appoint ASSIGNEE and its duly authorized agents as my agent and attorney in fact (which designation and appointment shall be (i) deemed coupled with an interest and (ii)

irrevocable, and shall survive my death or incapacity), to act for and in my behalf and  
stead to execute and file any such application or applications and to do all other lawfully  
permitted acts to further the prosecution and issuance of letters patent or other  
analogous protection thereon with the same legal force and effect as if executed by me;

AND I do hereby authorize and request the Director of the United States Patent  
and Trademark Office to issue any and all letters patent which may be granted upon  
said United States applications, or upon said improvements or any parts thereof when  
granted, to said ASSIGNEE;


I hereby grant the firm of Nancy J. Flint, Attorney At Law, P.A. the power to insert  
on this assignment any further identification, including the application number and filing  
date, which may be necessary or desirable in order to comply with the rules of the  
United States Patent & Trademark Office for recordation of this document.
