ASSIGNMENT

WHEREAS, we, JOSEPH M. MCMAHON, SCOTT ALEXANDER GILMOUR, ADAM MICHAEL MOEHLAU, JOSH YAGY and DANIEL J. HUTCHINSON, have invented certain new and useful improvements in a MACHINE FOR REMOVING SUBSTRATE MATERIAL, FOR WASHING, AND FOR DRYING PARTS PRODUCED BY A 3-D PRINTER, for which a provisional application for a patent in the United States was filed on June 16, 2015, that has been assigned U.S. Patent Application No. 62/180,476 and for which a U.S. non-provisional patent application is being filed (the "Applications"); and

WHEREAS, Audubon Machinery Corp., having its principal place of business at 814 Wurlitzer Drive, North Tonawanda, New York 14120 ("Audubon"), is desirous of acquiring all right, title and interest in and to the Applications, the invention described therein, and any and all applications and patents claiming priority therefrom.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to us in hand paid, the receipt and sufficiency of which is hereby acknowledged, we hereby assign, sell, transfer, convey and set over to Audubon, free and clear of all liens, encumbrances and other restrictions or obligations, any and all of our right, title and interest in and to (i) the Applications; (ii) all inventions described in the Applications and all patent applications relating thereto which have been or shall be filed in the United States, its territorial possessions and/or any foreign countries; (iii) all applications claiming the benefit of the filing date or claiming priority, directly or indirectly, from any of the foregoing, including without limitation any and all non-provisional applications, divisional applications, continuation applications, continuation-in-part applications, reissue applications, reexaminations, PCT and corresponding international, regional, national and other foreign applications ("Related Applications"); (iv) all rights, including without limitation all priority rights, under any international conventions, unions, agreements, acts and treaties; (v) all patents issuing or reissuing, directly or indirectly, from any of the foregoing; and (vi) all claims for damages or injunctive relief by reason of infringement of any of the foregoing, with the right to sue for past and future infringement and to collect damages for the same for Audubon's own use and benefit and for the use and benefit of Audubon's successors, assigns and other legal representatives (all of the foregoing hereafter referred to collectively as the "Patent Rights").

AND, we do hereby authorize and request that any patents issued from any of the foregoing patent applications be issued to Audubon, as the assignee of the entire right, title and interest thereto.

AND, we do hereby agree to execute, upon request of Audubon and at Audubon's expense, any and all documents that Audubon deems necessary or convenient to vest or record title in and to any of the Patent Rights in Audubon, and to provide such other material, information or assistance related to the Patent Rights as Audubon may deem necessary or convenient.

AND, we do further understand, confirm and acknowledge that in executing this document, we are transferring our entire interest in and to the Patent Rights to Audubon, and that the attorney(s) appointed in the Applications and any Related Application(s) also represent Audubon and any other co-inventor(s) identified in the Applications or Related Application(s). We consent to such multiple representation for the purpose of prosecuting any of the foregoing patent applications, and do hereby authorize the attorney(s) to take all future instructions from Audubon. We are unaware of any potential interest that we may have that differs from, or is adverse to, that of Audubon with respect to the prosecution of the foregoing patent applications, and we further acknowledge that, prior to executing this document, we did not seek or obtain any legal advice from Audubon's attorney(s) with respect to this Assignment and that we have been informed of our right to seek independent counsel of our own choosing and at our own personal expense.




