## ASSIGNMENT

WHEREAS, we, **Hyung T. Kwak**, a citizen of the United States of America, **Ali A. Al-Yousif**, a citizen of Saudi Arabia, and **Salah H. Al-Saleh**, a citizen of Saudi Arabia, are inventors of **ABSOLUTE POROSITY AND PORE SIZE DETERMINATION OF PORE TYPES IN MEDIA WITH VARYING PORE SIZES** for which a provisional application for United States Letters Patent was filed on **March 7, 2017**, and assigned Serial No. **62/468,176**; and non-provisional application for United States Letters Patent was filed **March 6, 2018**, and was assigned Application No. **15/913,171**; and

WHEREAS, Saudi Arabian Oil Company, a Company with Limited Liability of Saudi Arabia, with a business address of 1 Eastern Avenue, Dhahran 31311, Saudi Arabia, hereafter "SAUDI ARAMCO", is desirous of acquiring the entire right, title and interest in and to the aforesaid invention throughout the world, and all right, title and interest in, to and under any and all Letters Patent of the United States and all other countries throughout the world;

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) to us in hand paid by SAUDI ARAMCO and for other good and valuable considerations, the receipt of which is hereby acknowledged, we hereby sell, assign, transfer and set over to SAUDI ARAMCO, all our right, title and interest in and to the said invention throughout the world, and said application for U.S. Letters Patent, and any and all divisions, continuations, reexaminations and reissues thereof, and any and all Letters Patent of the United States and foreign countries which may be granted therefor, the same to be held and enjoyed by them for their own use and benefit, and for the use and benefit of their successors, assigns, or other legal representatives, to the end of the term or terms for which said Letters Patent of the United States or foreign countries are or may be granted, reexamined or reissued, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.

And we hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said invention or resulting from said application and from any and all divisions, continuations, and reissues thereof, to SAUDI ARAMCO, as assignee of the entire interest, and hereby covenant that we have the full right to

convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.

And we further hereby covenant and agree that we will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention and to such Letters Patent as may be granted therefor, to SAUDI ARAMCO, its successors, assigns, or other legal representatives and that if SAUDI ARAMCO shall desire to file any divisional or continuation applications or to secure a reexamination or reissue of such Letters Patent, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation application, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.


And we do further covenant and agree that we will, at any time upon request, communicate to SAUDI ARAMCO, its successors, assigns or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to us, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.


