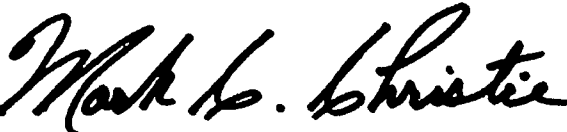

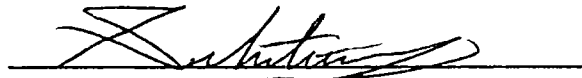
**ARTICLES OF MERGER OF
GLOBALCERTS, LC AND GLOBALCERTS, LLC**



The undersigned, on behalf of the eligible entities set forth below, pursuant to Title 13.1, Chapter 12, Article 13 of the Code of Virginia, state as follows:

1. GlobalCerts, LC a Virginia limited liability company, shall be merged into GlobalCerts, LLC a California limited liability, which will be the surviving entity.
2. GlobalCerts, LC and GlobalCerts, LLC have adopted a Plan of Merger. The Plan of Merger provides that at the effective date of merger:
 - A. the surviving entity shall thereupon possess all the rights, privileges, immunities and franchises of GlobalCerts, LC, and all property, real, personal and mixed, and debts due on whatever account, and every other interest belonging to or due to GlobalCerts, LC shall be deemed to be transferred to and vested in GlobalCerts, LLC as the surviving entity, without further act or deed;
 - B. All membership interests in GlobalCerts, LC will be transferred to GlobalCerts, LLC.
3. The plan of merger was adopted by unanimous consent of the members of GlobalCerts, LC and GlobalCerts, LLC on December 20, 2017. A certificate of merger was filed with the Secretary of State of California on December 22, 2017, with an effective date of December 31, 2017.
4. GlobalCerts, LLC certifies that its participation in the merger was duly authorized as required by the laws of the state of California.
